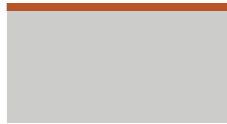

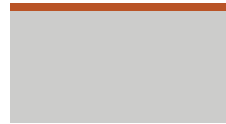

Do you own a restaurant, bar, club or hotel?



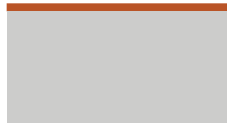
2nd Class License

Are you a store that sells beer, wine or tobacco?



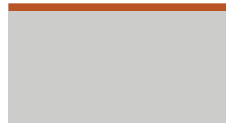

Do you produce beer, wine or spirits?



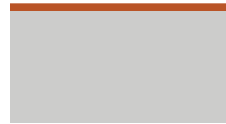
